<u>Welcome and Introductions</u>- Natalie Jackson called the meeting of the Southeastern Virginia Homeless Coalition (SVHC) to order at 12:35pm..

<u>Approval of the Minutes – March 08, 2023 – John Guglielmino made a motion to approve the minutes with no noted corrections.</u> Alicia Matthews seconded the motion. The minutes were approved for the March 08, 2023 meeting.

#### **Project Hope Overview**

Lynne Carruth, Project Analyst with Project Hope, provided an overview of the program. Project HOPE-Virginia is Virginia's program for the Education of Homeless Children and Youth. William & Mary administers the program for the Virginia Department of Education. Funding is authorized under the McKinney-Vento Homeless Education Assistance Act, Title IX, Part A of the Every Student Succeeds Act (P.L. 114-95). Every Virginia K-12 school division has a school liaison who will ensure the enrollment, attendance, and school success of children and youth experiencing homelessness. Project HOPE provides regular subgrants of state/federal funding to local school divisions as well as training, oversight, and technical assistance. School divisions use funds to develop customized programs to meet the student's needs. Services can include emergency assistance, referrals for health services, transportation, school supplies and obtaining school records.

#### American Rescue Plan-Homeless Children & Youth (Arp-Hcy) Funding

In 2021, Virginia received \$13,000,000 in ARP-HCY funding to assist K-12 students and their families, experiencing homelessness. The grant expires September 30, 2024.

- Purpose of the ARP-HCY grant: To support the identification, enrollment, and school participation of students experiencing homelessness, including through wrap-around services.
- Funds may be used for any expense listed in the original McKinney-Vento legislation. Each school division has developed a plan for expending these funds.

#### **Funding Updates**

#### Federal - Continuum of Care Homeless Assistance Awards - Hampton Roads

Natalie Jackson provided an overview of the cumulative \$9,143,388 in homeless assistance awarded to Continuums of Care within the Hampton Roads geographical area from the Department of Housing and Urban Development's (HUD) FY2022 CoC competition. HUD expects to announce the FY2023 Notice of Funding Opportunity for the FY23 CoC Program Competition within the coming weeks, in which the SVHC CoC will apply.

# State -Department of Housing and Community Development – Virginia Homeless Solutions Program (VHSP) and Housing Trust Fund Homeless Reduction Grant (HTF)

Natalie Jackson provided an overview of the funds awarded to the CoC through the VHSP and HTF programs for FY2023. The CoC was awarded \$1,363,898 through VHSP. Additionally, five agencies within the CoC were awarded funds through the HTF grant to include: ForKids Inc., Senior Services of Southeastern Virginia, S.T.A.R. Haven, Virginia Supportive Housing, and YWCA South Hampton Roads for a cumulative of \$1,008,958 within the CoC.

#### **Point in Time Count and Housing Inventory Count Update**

Data from the 2023 Point in Time Count and Housing Inventory Count is now available to the CoC. During the sheltered count 523 persons were identified in Emergency Shelter and 20 persons were identified as sheltered in Transitional Housing. In addition, 110 people were identified as unsheltered during this year's count which was an increase from the previous year.

#### Roundtable Updates and Resources

- Senior Services will be hiring an outreach worker. The posting will be announced on the agency's website.

  Additionally, Fatima Tomlin, Homeless Older Adults Program Manager, will be doing office hours at PrimePlus Norfolk twice a month for seniors at risk of homelessness to ensure they are connected to the appropriate services.
- South Norfolk Memorial Library The first Thursday of each month is Community Services Day where agencies come to connect those in need with benefits and services.
- SVHC General Membership Meetings have transitioned to a quarterly meeting schedule.
