Single Adult Barrier Reduction Exchange 2 (SABRE 2) provides permanent supportive housing (PSH) in the city of Portsmouth with supportive services. SABRE 2 will serve up to 13 Chronic Households: Up to 12 with Single Adults with no children and at least 1 Chronic Household with at least one adult and at least one child. The program will remain Dedicated Plus and continue to dedicate 13 beds for chronic participants.

-The program will use the Portsmouth Homeless Action Consortium (PHAC) Coordinated Entry System (CES) to receive referrals for placement into a SABRE 2 Permanent Support Housing unit. SABRE 2 adheres to core philosophies and practices of Housing First and participant choice in all decision making regarding housing. Therefore, after housing is in place and as housing is located, housing and income stabilization case management supportive services will be provided to resolve any barriers to housing and employment as identified through the assessment process. As a low barrier program, no id documentation is required for referral. PARC will assist enrollees with obtaining any needed documentations.

-Participants will be assessed for Supportive Services throughout their time spent in the program. Participants will be encouraged to use supportive services available for improving quality of life, increase income opportunities and sustaining housing. Upon initial enrollment in SABRE 2, PARC will connect participants to mainstream services such as SNAP (Supplemental Nutrition Assistance Program), Medicaid, connections to Social Security benefits through the SSI/SSDI Outreach, Access and Recovery (SOAR) or the local Social Security Administration Vulnerable Population Liaison.

-Additional Supportive Services offered will include but are not limited to: referrals for employment counseling and search; mental health, substance use, medical and dental care; in-home support services; basic life skills support; tenancy stabilization skill development; landlord mediation; budgeting; and increasing community integration through volunteerism, classes, and employment.

For Supportive Services not provided by PARC staff, PARC will facilitate participant referrals to Partner and Non-Partner agencies specializing in providing the identified needed Supportive Service..

Portsmouth Department of Behavioral Health Services (PDBHS) partners with PARC to provide mental health case management services to several PARC clients.

Program participants will be periodically assessed and where feasible positioned to move into subsidized or non-subsidized permanent housing. Eligible participants will be connected to local mainstream subsidized housing resources, such as local public housing authority. PARC will provide follow up services to those who move on to assist with transition from the program for at least six months or as budget allows.
