For Leasing, there was money left over due to not not being able to receive eligible referrals from the COC coordinated assessment process which left PARC short one participant.

Step Up to Responsibility Plus (SUTR Plus) provides permanent supportive housing (PSH) located in the city of Portsmouth with supportive services. SUTR Plus will serve up to 6 Households; 4 Adult Households with no children and 2 Households with at least 1 adult and at least 1 child. The program will remain Dedicated Plus and dedicate 2 beds for chronic participants. The program will only use the Portsmouth Homeless Action Consortium (PHAC) Coordinated Entry System (CES) to receive referrals for placement into a SUTR PLUS Permanent Support Housing unit. SUTR PLUS adheres to core philosophies and practices of Housing First and participant choice in all decision-making regarding housing. Therefore, after housing is in place and as housing is located, housing and income stabilization case management supportive services will be provided to resolve any barriers to housing and employment as identified through the assessment process. As a low barrier program, no id documentation is required for referral. PARC will assist enrollees with obtaining any needed documentations. Participants will be assessed for Supportive Services throughout their time spent in the project. ARTICLES OF INCORPORATION
OF
PORTSMOUTH AREA RESOURCES COALITION, (PARC), INC.

We, the undersigned, hereby associate ourselves to establish a non-stock corporation under Chapter 2 of Title 13.1 of the Code of Virginia, as amended, and claim the benefit of non-profit status, pursuant to Section 501 (c) (3) of the Internal Revenue Code and its Regulations as they now exist or may be amended, and to that end set forth as follows:

ARTICLE I

The name of the corporation is PORTSMOUTH AREA RESOURCES COALITION (PARC), INC.

ARTICLE II

The purposes for which the corporation is formed are as follows:

- A. To increase the availability of food and other emergency assistance to those in need residing in Portsmouth and the Deep Creek and Western Branch Boroughs of Chesapeake through the combined and coordinated efforts of the membership;
- B. To develop and maintain a constant awareness of the changing assistance needs throughout the designated area; and
- C. To promote better understanding of emergency assistance needs in the designated area, and to work for the prevention of related social ills as well as their cure.

K. The nominating committee of the corporation shall

submit the name(s) of individuals who are organized

solely for benevolent, educational and charitable purposes

and the corporation shall have no power to engage in any

activity, or use its funds in any manner which would deny it

exemption from taxation under the aforesaid provision of the

Internal Revenue Code and its Regulations as they now exist

or may be amended. Under no circumstances shall any part of

the net earnings of the corporation inure to the benefit of

any individual nor under any circumstances shall any of the

assets of the corporation be distributed, in liquidation, or

otherwise, to any individual.

E. No substantial part of the activities of the corpo-

ration shall be the carrying on of propaganda, or otherwise

attempting to influence legislation; and the corporation

shall not participate in, or intervene in (including the

publication or distribution of statements) any political

campaign on behalf of any candidate for public office.

F. The corporation shall not discriminate against any

person on the basis of race, color, sex, or religion in its

membership process, provision of services to the community,

or in any other manner.

ARTICLE III

The corporation shall have at least 10 members. The

election of members to the corporation shall be conducted as

follows:

A. The nominating committee of the Board of Directors shall submit the name(s) of individuals and/or organizations for membership who have indicated interest in and support for the goals and purposes of the corporation, commitment to and fulfillment of the membership criteria and operational policies as established by the Board of Directors, and willingness to assist or serve as needed in any advisory or consultative capacity or as an active participant.

B. The members of the corporation shall be elected by majority vote of the directors of the corporation at any duly constituted meeting of the directors, upon fulfillment of the criteria established by the Board.

ARTICLE IV

Upon the dissolution of the corporation or the winding up of its affairs, the assets of the corporation shall be distributed exclusively to charitable, religious, scientific, literary, or educational organizations which would qualify under the provision of Section 501 (c) (3) of the Internal Revenue Code and its Regulations as they now exist or as they may hereafter be amended.

ARTICLE V

The registered office of the corporation is to be located in the City of Portsmouth, Virginia. The post office address of the initial registered office of the corporation is Dominion National Bank Building, Suite 420,

P.O. Box 1418, Portsmouth, Virginia 23705-1418. The name of the initial registered agent is Doris L. Perry, who is a resident of Virginia and a member of the Virginia State Bar, and whose business address is the same as the address of the initial registered office of the corporation.

ARTICLE VI

The affairs of the corporation shall be managed by a Board of Directors to be in number not less than 7 nor more than 13. At the first annual meeting of the members, one third of the total number of directors, as specified in the by-laws, shall be elected for one year terms, one third of the total for two year terms, and one third of the total for three year terms. Thereafter, one third of the total number of directors, as specified in the by-laws, shall be elected annually at the annual meeting of the members to serve for three years, with one third of the total number of directors rotating each year. The Board shall be composed of officers of the corporation, and a sufficient number of members of the corporation to meet the number of directors specified in the by-laws. The registered agent shall serve as an ex-officio director, but shall have no voting rights or privileges. The number of directors constituting the initial Board of Directors is eleven (11); said number excludes the registered agent. The initial directors shall serve until the first annual meeting of the members. The names and addresses of the persons who are to serve as the initial directors are:
