Portsmouth Behavioral Healthcare Services (PBHS) Shelter Plus Care (S+C) follows the guidance of Notice CPD-14-012. As a member of the CoC, S+C uses the Order of Priority as set out in Notice CPD-14-012. Those chronically homeless individuals with the most severe service needs are given first priority. Outreach to find chronically homeless individuals and families is fulfilled through various sources including but not limited to Projects for Assistance in Transition from Homelessness (PATH), Virginia Supportive Housing (VSH), Portsmouth Volunteers for the Homeless (PVH), STOP, Inc. and Wounded Warriors. Referrals are made through those programs to the Homeless Hotline and presented by various support agencies throughout the city of Portsmouth through the coordinated entry system. Data used to determine the Order of Priority is gathered through the Portsmouth CoC central intake process which includes a variety of assessment tools, including the VI-SPDAT.

Portsmouth Behavioral Healthcare Services S+C adheres to Housing First principles as described in Section III.A.3.d of the FY 2014 CoC Funding Notice. Applicants are accepted regardless of lack of income, actively using substances, criminal convictions or not receiving supportive services. The first priority is to get the applicant into housing and then address the barriers that have previously kept them from finding and/or maintaining independent housing. S+C has developed relationships with a large number of property owners, some of whom are willing to accept tenants in spite of previous legal and credit problems.

S+C connects residents with any program that will benefit them in an attempt to remove barriers and provide services needed. Residents receive services from approximately 35 different public and private agencies. Many of the agencies provide services for Medicaid eligible individuals in order to maximize Medicaid billing. Through Portsmouth Behavioral Healthcare Services (PBHS), Case Management, Outpatient Services, Medication Management, Psychosocial Rehabilitation, Mental Health Skill Building and Part C are some of the services available to eligible individuals in the S+C program. For individuals that are determined to be non-Medicaid eligible, PBHS leverages SA and MH federal block grant and state MH, SA and ID service dollars which are available to assist with the support the needs of S+C residents.

- Case Management. Grant funds can be used to pay staff time necessary to assess, coordinate, and implement emergency transfer(s).
- Housing Navigation. Grant funds can be used to pay staff time necessary to identify safe units and facilitate moves into housing for survivors through emergency transfer(s).
- Technology to make an available unit safe. Grant funds can be used to pay for technology that the individual believes is needed to make the unit safe, including but not limited to doorbell cameras, security systems, phone, and internet service when necessary to support security systems for the unit, etc.

- Monitoring and evaluating compliance.
- Developing and implementing strategies for corrective actions and remedies to ensure compliance.

- Reporting to CoC Collaborative Applicant, HUD, and other interested parties on compliance with VAWA confidentiality requirements.
- Costs for establishing methodology to protect survivor information.
- Staff time associated with maintaining adherence to VAWA confidentiality requirements.


