St Columba Ecumenical Ministries notified the CoC of their intention to reallocate the funding in February 2024. On February 27, 2024, The Planning Council notified the CoC partners and community that the reallocated funds would be available during the FY2024 CoC Competition.

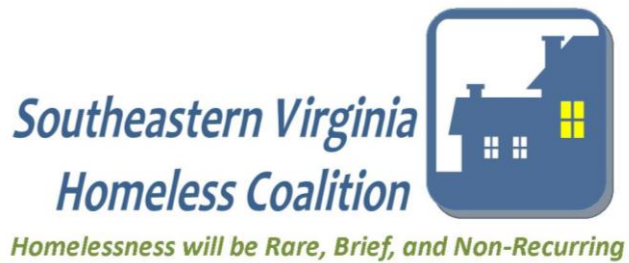




