continuum of state- and federallyfunded homeless service
programs to address housing and
stabilization services for
individuals and families at-risk of
or experiencing homelessness in
the commonwealth.





State Goals:

- To reduce the length of homelessness
- To reduce the number of new cases of homelessness
- To reduce the number of individuals returning to homelessness

HSNH Funding

VHSP and HOPWA Funding will be administered based on a two-year funding cycle

- Year 1, July 1, 2024 June 30, 2025, Basis Grant Application
- Year 2, July 1, 2025 June 30, 2026, Basis Renewal, fund availability, and performance

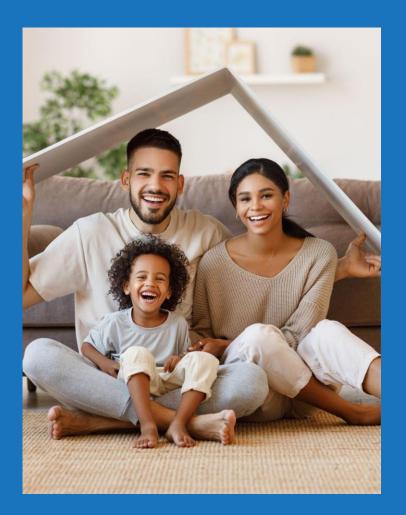

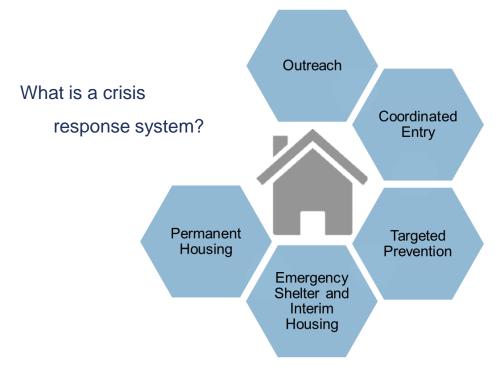

Emergency Crisis Response System





Role of the CoC/LPG

- Governance and structure
- System coordination and planning
- Designating and operating HMIS
- Coordinated Entry





Virginia Homeless Solutions Program (VHSP)

- VHSP supports the emergency crisis response system, a housing-focused approach to ensure homelessness is rare, brief, and one-time through coordinated community-based activities.
- Goals of VHSP:
 - To assist households experiencing homelessness to quickly regain stability in permanent housing
 - To prevent households from becoming homeless.



VHSP Funding

Funding Sources (approx. annual amounts)*

| Name | Source | Amount |
|--|--------------|--|
| Emergency Solutions Grant | Federal- HUD | \$2,820,422 |
| Homeless General Funds- Homeless Assistance | Virginia | \$8,689,210 (including \$1.1 million for RRH, \$100,000 of which is veteran- specific) |
| State General Funds- Homeless Prevention | Virginia | \$3,969,000 |
| | Total | \$15,478,632 |

 *Actual funding levels have not been determined as of this presentation and could vary significantly from estimated amounts





Match Requirements

- VHSP requires a 25% match based on the total amount of funds allocated within the CoC/LPG (applies to VHSP funds only).
- Match requirement may be met at the community and/or grantee level.
- See page 19 of the HSNH-VHSP guidelines for the full listing of match requirements.

- Non- profit organizations (current on 990 filings)
- Units of local government
- Housing Authorities*
- Planning District Commissions*

*excludes shelter operations and rapid re-housing

- Harm Reduction

VHSP Eligible Activities

- Outreach
- Centralized or Coordinated Assessment/Entry System
- Targeted Prevention
- Emergency Shelter Operations
- Rapid Rehousing
- CoC/LPG Planning
- HMIS (or comparable system)
- Administration





VHSP Eligible Activities – Indirect categories

- CoC/LPG Planning
 - Capped at 10%
- HMIS (or comparable system)
 - Capped at 5%
- Administration
 - Capped at 5%





Reminder: FMR Waiver

- The FMR waiver for all state funds administered by HSNH will remain in effect.
- Waives the FMR requirement for all assisted units. All other unit eligibility requirements, including rent reasonableness, apply.
- Programs and activities impacted:
 - VHSP Prevention
 - VHSP State Rapid Rehousing
 - HTF Homeless Reduction Grant (all project types)
 - *to utilize the FMR Waiver contact your Program Administrator



Key Outputs and Performance Measures

Agencies will be required to report on the following outputs based on HUD's System Performance Measures (mid year and end of year reports):

- Demographics
- Permanent housing placements (Destinations)
- Length of time receiving financial assistance (Targeted Prevention and RRH)
- Length of time receiving case management (Targeted Prevention and RRH)
- Capacity and utilization (Emergency Shelter Operations)
- Prior Living Situations



Key Outputs and Performance Measures

- During agency and system monitoring, evaluations of the following processes will occur:
 - Ensuring that all households at the entry point are assessed with a standardized assessment tool
 - Entry point(s) are low-barrier and easily accessible
 - Service providers refer appropriate households seeking shelter to the entry points
 - Appropriate written policies and procedures are implemented (DHCD must review and approve these and all revisions)
 - Individualized housing-focused case management is provided





HOPWA Assistance

- The HOPWA program goals are to assist eligible households to maintain housing stability.
- Funds will be focused on direct housing assistance and supportive services to those most in need.



HOPWA Grantee Requirements

- Financial Training
- HOPWA Housing Quality Standards
- Confidentiality
 - See page 43 of the HSNH Guidelines for a comprehensive list.



HOPWA Eligible Activities

- Tenant- Based Rental Assistance (TBRA)
- Short Term Rental, Mortgage, and Utility Assistance (STRMU)
- Supportive Services
 - Permanent Housing Placement
- Housing Information Services
- Administrative Costs



HSNH 2024-2026 Application

- Submitted through the Centralized Application and Management System (CAMS)
 - Must have CAMS Organizational Profile
- 1 application per CoC/LPG, submitted by lead agency
- Deadline for submission: 11:59 PM on April 5, 2024
- Technical assistance is available upon request

Accessing Application Instructions & Guidelines

- Go to the DHCD website, <u>www.dhcd.virginia.gov</u>
- 2. Click on <u>Access CAMS</u> button in the upper right corner
- 3. Login to CAMS (or, click <u>Registration</u> if the organization does not have a profile)
- 4. Click Apply from the top menu. This takes you to "Apply for Funding" page
- 5. Select <u>Homeless and Special Needs Housing 2024-2026</u> from the drop down menu, click <u>Go</u>
- 6. Links to HSNH application instructions and HSNH 2024-2026 guidelines are shown here



Accessing Application

- 1. From the "Apply for Funding" page, find the pencil to the right of the program name and click "Apply"
- 2. Enter your project name.
 - Example: Prince William Area CoC HSNH 2024-2026
- 3. This starts your application
- 4. To access a saved application, select <u>Application Status</u> from the top menu
- 5. Your saved application will be listed under "Incomplete Applications"



Application Sections

- Part 1: Community Analysis and Processes
- Part 2: Proposed Grantees (VHSP + HOPWA)



Budget Guidance: Base Request

- The base request is total from Outreach, Emergency Shelter Operations, Rapid Re-housing, Targeted Prevention, and Centralized or Coordinated Assessment/ Entry.
- Indirect activities have caps set by base request. Example:

| Total base request | \$ 100,000 |
|--------------------------|------------|
| CoC Planning (up to 10%) | \$ 10,000 |
| HMIS (up to 5%) | \$ 5,000 |
| Admin (up to 5%) | \$ 5,000 |
| Total VHSP Request | \$120,000 |





Narrative Guidance

- Thoroughly answer the questions, do not assume anything
- Utilize quantitative data as much as possible to detail need, gaps, performance. Add qualitative data when necessary and available.
- Make sure that all components of a question are addressed in the response.
- Ensure application process is open and transparent, include process for grievance and resolution.
- Provide real examples of coordination and implementation of best practices.

Scoring Criteria

Community Need and Performance Outcomes – 25%

CoC/LPG-level Approach and Local Coordination – 50%

Proposed grantee-level capacity and approach – 25%
