The Portsmouth Housing First project is a scattered site Permanent Supportive Housing (PSH) program for individuals experiencing chronic homelessness. Portsmouth Housing First is funded for 12 units.

Support services and housing stabilization ensure housing retention and positive outcomes. The program focuses on outcomes that address ending chronic homelessness, ensuring housing stabilization, provision of and connection to services and resources for stabilization and wellness, improving income, and graduations to self-sufficiency and affordable housing.

Services and resources are provided by VSH staff and with partners such as the Hampton Roads Community Health Clinic (Health for the Homeless and FHC), Hampton Roads Dental Clinic, Portsmouth Department of Behavioral Health, Chesapeake Community Services Board (PACT program Portsmouth/Chesapeake), Oasis Social Ministry, EVMS Clinic, Sentara Ambulatory Care Clinic, Bon Secours Care-A-Van, Social Security, Department of Rehabilitative Services, Portsmouth Social Services, and the Veterans Administration.

Services include but are not limited to: in-home support services; basic life skills support; connections to benefits through the SSI/SSDI Outreach Access and Recovery (SOAR) model; access to medical, mental health, and dental care; tenancy stabilization skill development; landlord mediation; budgeting; and increasing community integration through volunteerism, classes, and employment. In addition to helping residents connect to mainstream services and resources, VSH provides many services in partnership with other organizations for mental health, substance use, medical and dental care.

- Housing Navigation. Grant funds can be used to pay staff time necessary to identify safe units and facilitate moves into housing for survivors through emergency transfer(s).
- Technology to make an available unit safe. Grant funds can be used to pay for technology that the individual believes is needed to make the unit safe, including but not limited to doorbell cameras, security systems, phone, and internet service when necessary to support security systems for the unit, etc.
